LOGAN FISCAL COURT

WHEREAS, KRS Chapter 61 and Annual Periodicals published by Kentucky Attorney General Office set forth the minimum responsibilities of a governmental entity comply with the Kentucky Open Records Act.

WHEREAS, Logan County Fiscal Court desires to formalize out internal regulations governing open records request.

NOW, THEREFORE, LET IT BE RESOLVED AS FOLLOWS:

Pursuant of KRS 61.870 to 61.884, the public is notified that, as provided herein, the public records of the above named Agency of the Commonwealth of Kentucky are open for inspection by any person eligible for such records as governed by KRS Chapter 61 on written application to Logan Chick, Logan County Judge- Executive office custodian of the Logan County Fiscal Court whose address is 200 West 4th Street, P.O. Box 365 Russellville, KY., from 8:00 am to 4:00 pm, Monday through Friday, each week, except holidays. Application forms for the inspection of the public records of this agency will be furnished on request to any person by an employee in this office. A sample Request Form is attached. Email requests for records should be sent to open records and should include a mailing address.

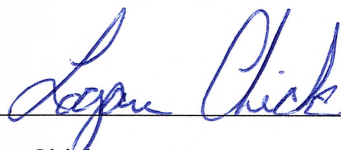
Applicants for the inspection of public records shall be advised of the availability of the records requested for inspection, and shall be notified in writing not later than five (5) working days after receipt of an application for inspection of any reason the records are not available for public inspection.

Copies of written material in the public records of this agency shall be furnished to any person requesting them on payment of a fee of ten (10) cents per page: copies of non-written records (photographs, maps, materials stored in computer files or libraries, etc.) shall be furnished on request, on payment of a charge equal to the actual cost of the producing copies of such rewords by the most economic process not likely to damage or alter the record.

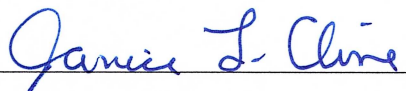
